Church Way, Bedworth - Proposed Informal Raised Pedestrian Crossing

Recommendation

That the proposed informal raised pedestrian crossing, funded and championed by Nuneaton and Bedworth Borough Council should be implemented on Church Way, Bedworth as advertised.

1. Introduction

- 1.1 Following the formal advertisement of a proposed raised informal pedestrian crossing on Church Way, one objection from a resident has been received relating to the proposal. This report considers the objection and recommends that the informal raised pedestrian crossing point be implemented as advertised.
- 1.2 The proposal consists of an informal raised crossing point along Church Way. This will provide a raised table that will allow pedestrians to cross the road at footway level and will slow vehicles on approach. The informal crossing will not however give pedestrians formal right of way over traffic. The proposal is shown in Drawing No: RSE/11-12/043V/101 as **Appendix A.**

2. Background

- 2.1 Church Way Bedworth is a "D" Class road providing access to Aldi, Bedworth Market, a small number of retail outlets and a number of residential flats. The road is not a through route and terminates near a number of garages associated to the residential flats and rear access to a number of retail outlets.
- 2.2 There is significant pedestrian activity within the vicinity of the proposal with pedestrians accessing Bedworth Market, Aldi and crossing from Congrave Walk.
- 2.3 Nuneaton and Bedworth Borough Council have approached Warwickshire County Council with a request to install a raised pedestrian crossing point across Church Way from Bedworth Market to a proposed pedestrian only access point into the Aldi car park. The Borough Council have agreed to pay for the construction of the scheme and all other associated costs.
- 2.4 It is envisaged that the crossing point will assist all pedestrians but particularly the more vulnerable and less mobile pedestrians in the area accessing the Market, Aldi and crossing from Congrave Walk.



5. Formal Consultation

- 5.1 Consultation has been carried out with the Local Member, Nuneaton and Bedworth Borough Council, Warwickshire Police, the Fire Brigade, The Ambulance Service, Road Haulage and Freight Associations, Disabled Drivers Association, Market Traders and residents and businesses along Church Way and Congrave Walk.
- 5.2 The Police have no objection to the proposals and have commented that it is entirely appropriate to the nature of the road.
- 5.3 The local Member, Councillor Richard Chattaway has inspected the proposals and is happy for the scheme to be put forward.
- 5.4 The proposal is supported by the Market Traders at Bedworth Market when discussions were undertaken during the letter drop.

6. Objections

- A Legal notice advertising the proposed feature was placed in the Nuneaton Weekly Tribute on the 4 November 2010, with the objection period ending on the 6 December 2010. Yellow backed notices were also placed on street to inform local people and advise them of their right to object.
- 6.2 One letter of objection from a resident of Church Way was received and raised the following points:-

6.3 Objection 1

Point (i)

The feature will cause major problems in accessing the residential properties along Church Way and cause great delays in leaving them.

Response

The single feature is designed to provide minimum discomfort for road users by incorporating a relatively shallow on/off ramp and a relatively long flat top/plateau length. It is not envisaged that proposed single feature will introduce any significant delay for vehicles accessing properties serviced by Church Way.

Point (ii)

The proposals do nothing to address the inappropriate parking along Church Way and the issues associated with accessing properties.

Response

The scheme has not been designed to address parking issues along Church Way. It is accepted that there appears to be a high number of "blue badge"



holders parking legitimately on the existing double yellow lines and that it may be causing problems for residents and market traders. Environment and Economy Directorate are aware of the issue and will review the situation when the wider parking issues at Nuneaton and Bedworth are investigated in 2011. The objector has been invited to a site meeting to discuss the issues but no response to the invitation has been received.

7. Conclusion

- 7.1 The advertised proposals have general support and will provide an improvement for pedestrians along Church Way.
- 7.2 It is recommended that the proposed informal raised pedestrian crossing along Church Way be implemented as advertised.
