MEET RULES AND CONDITIONS

- 1 The competition is a Level 4 licensed meet, held under Swim England Laws, Swim England Technical Rules of Swimming, and these conditions.
- 2 The competition is only open to members of Hoddesdon Swimming Club.
- 3 The promoters are Charlotte Keens, Gemma Stacey, and Paula Renouf on behalf Hoddesdon Swimming Club.
- 4 Medals will be awarded to 1st, 2nd and 3rd placed swimmers in each age group.
- 5 The age groups for boys and girls are: 10/under, 11/12, 13/14, 15/16, 17/over
- 6 Age is as 31st December 2022.
- 7 Events are 50m,100m,200m freestyle, breaststroke, butterfly, and backstroke.
- 8 25M events will be open to academy squad swimmers. These races will be informal, and results will not be submitted to British Ranking. These races are to enable our younger swimmers to participate in a club event and gain experience in competitive swimming. Age groups for boys and girls will be 7/8, 9/10, over 11.
- 9 The pool is 25m and anti-wave devices will be in place.
- 10 Heats will be swum as mixed age with swimmers seeded by entry times.
- 11 Over the top starts may be used at the referee's discretion.
- 12 The cost of each event will be £2.00 with a £1.00 admin fee per swimmer . Entry will be by Google forms found on Hoddesdon Swimming Club Website. Payment by BACS transfer to Hoddesdon Swimming Club Treasurer. Bank details to be supplied when entry period opens. The closing date for entries will be 23/09/2022.
- 13 Results will be displayed poolside after each event and the club website within 1 week. Results will be supplied to Swim England for entry into the national ranking database.
- 14 In accordance with the Swim England Child Safeguarding Policies and Procedures, any parents or carers of swimmers under the age of 18 who wish to take photographic, or video images are requested to focus on their own child as much as reasonably possible and to avoid including other children in those images. Should you have any concerns about photography or filming please bring them to the attention of the promoter.

Participants and spectators are requested to follow the Swim England guidelines for photography and use of photographs on social media. No photography is permitted in changing rooms. Any person found to be contravening this condition will be required to leave the competition and venue without refund.

- 15 All participants must observe the safety precautions in operation at John Warner Sports Centre and Haileybury School Swimming Pool. Neither the Promoter nor Hoddesdon Swimming Club will be responsible for any loss or damage occurring during this meet.
- 16 The Data Protection Act 2018 requires us to provide you with certain information and to obtain your consent before processing data about you. Processing includes: obtaining, recording, holding, disclosing, destruction or retaining information. We require certain personal data for the purposes of making entries to the competition, managing the meet and the submission of results to Rankings. The information provided by you will be processed in accordance with the Data Protection Act 2018. Consent to process such personal data is deemed to have been given by the submission of the entry. Where the personal data of competitors, officials and coaches/team managers has been passed to us by a third party such as a club rather than by the individuals themselves, we rely on the third party to ensure that consent has been obtained.
- 17 Any matter not covered by these conditions will be determined by the Promoter and Referee, subject to Swim England Laws, Regulations and Technical Rules of Racing.
