MEET RULES AND INFORMATION

1. The competition is a Level 4 licensed meet, held under Swim England Laws, Swim England Technical Rules of Swimming and these conditions.
2. The competition is only open to members of Altrincham Swimming Club.
3. The promoter is Mrs Louise Pennington on behalf of Altrincham Swimming Club.
4. Medals will be awarded to any swimmers who achieve three “qualifying times”, in accordance with the Club’s Pointscore conditions, to move into the next competition group.
5. The competition is open to all members of Altrincham Swimming Club, both Club Train and Club Compete swimmers.
6. The schedule of events for each Pointscore is published on the Club website
7. The pool is 25m; anti-wave devices will be in place; and backstroke start ledges will be available. Dolphin Semi-Automatic timing will be used.
8. Heats will be swum as mixed age with swimmers seeded by entry times.
9. Age is as at 20 November 2022, the final Pointscore of the year.
10. Over the top starts may be used at the Referee’s discretion.
11. There are no entry qualifying times, the competition is open to all members of Altrincham Swimming Club.
12. There is no cost to enter. Entries must be submitted via Altrincham Swimming Club’s online entry system; entry window opens three weeks before each event (although this may vary depending on school holidays and Bank Holidays) and closes at midnight one week prior to each event.
13. Results will be posted in the Members Area of Altrincham Swimming Club website and will be supplied to British Swimming for entry into the national ranking database via Hy-Tek Meet Manager.
14. No photography is permitted unless by the express consent of the swimmers whose image(s) will be captured. No photography is permitted in changing rooms. Any person found to be contravening this condition will be required to leave both the competition and venue.
15. All participants must observe the safety precautions in operation at Altrincham Leisure Centre. Neither the Promoter nor Altrincham Swimming Club will be responsible for any loss or damage occurring during this meet.
16. The Data Protection Act 2018 requires us to provide you with certain information and to obtain your consent before processing data about you. Processing includes: obtaining, recording, holding, disclosing, destruction or retaining information. We require certain personal data for the purposes of making entries to the competition, managing the meet and the submission of results to Rankings. The information provided by you will be processed in accordance with the Data Protection Act 2018. Consent to process such personal data is deemed to have been given by the submission of the entry.
17. Any matter not covered by these conditions will be determined by the Promoter and Referee, subject to Swim England Laws, Regulations and Technical Rules of Racing.
